9. Correspondence

Cllr Cockrell had a message through Facebook from a resident concerned about the speeding through village which nearly knocked over a pedestrian and it is a cause for real concern. The resident was enquiring if the village could have average speed cameras.

Cllr Perry explained that it was beyond the council's control and the Highways Authorities only put average speed cameras on trunk roads and motorways. No UK villages have average speed cameras. Cllr Perry will continue to bring the issues related to the A48 to the attention of the Vale of Glamorgan Council.

Cllr Perry had a correspondent from a resident raising the issues of the tree in a Conservation Area – Cllr Perry is dealing with the issue.
