





# Appeal Decision

- The appeal is made under section 78 of the Town and Country Planning Act 1990 against a refusal to grant planning permission.
- The appeal is made by Mr & Mrs Andrew Donnelly, against the decision of The Vale of Glamorgan Council.
- The application Ref 2023/00351/FUL, dated 3 April 2023, was refused by notice dated 4 October 2023.
- The development is described as 'a proposed garage and greenhouse'.
- A site visit was made on 14 March 2024.

#### Decision

1. The appeal is dismissed.

#### **Procedural Matter**

2. The development has been substantially completed and the appeal therefore seeks retrospective planning permission.

#### Main Issue

The main issue is the effect of the development on the rural character and appearance of the area.

#### Reasons

- 4. The appeal site includes a residential detached barn conversion with associated driveway and garden situated outside of the settlement boundaries as defined in the adopted Vale of Glamorgan Local Development Plan (LDP) and within the Ely Valley and Ridge Slopes Special Landscape Area (SLA). The garage and greenhouse are situated to the west of the existing buildings within the curtilage of Homri Barn. The site rises to the south following the topography of the surrounding area, which is strongly rural in appearance and character.
- 5. Amongst other things, Policy MD2 of the LDP seeks a high standard of design in new development that should positively contribute to the surrounding environment. Policies MD11 and MD12 contain criteria relating to rural conversions and extensions to dwellings in the countryside which primarily seek to protect the rural character. In particular extensions should not be disproportionate in size to the original dwelling or unacceptably affect its contribution to the rural character.



- 6. The development is a sizeable, detached garage of over 12m in depth with a greenhouse attached to the rear. Although structures of similar size and scale are not necessarily unusual in rural areas, the garage and greenhouse in this case are sited within the curtilage of the residential barn conversion and are viewed in this context. The ridge and eaves height of the garage are significantly higher than the adjacent single storey barn conversion. As a result, the development's scale and size is disproportionate to the host dwelling. This coupled with its position, in line with the front elevation of the barn, results in it appearing as a dominant, rather than subordinate outbuilding to the dwelling.
- 7. Although smaller in size and height and of translucent material, the greenhouse is also a large modern addition to the barn conversion. Cumulatively, the development results in a domestic outbuilding of significant scale and bulk which detracts from the positive contribution the barn conversion makes to the rural character of the area.
- 8. The site is located on a private road which I accept results in a low level of traffic passing the site. Similarly, I accept that views from the village are minimal given the topography and landscaping. However, Public Right of Way (PROW) footpath S11/3/2 runs to the east of the site enabling public views of the development. Although the development is partially screened by the existing barn when approaching from the south east, due to its height and depth the rear of the garage and greenhouse are evident behind the main barn. The front gable of the garage is also clearly visible from the PROW when approaching from the north adjacent to Homri Farm. Even at this distance, due to its forward position and scale it appears as an incongruous addition to the curtilage of the site. As a result, and notwithstanding the use of matching stonework, the proposal's scale and jarring position results in an unsympathetic form of development visible in localised public views causing substantial harm to the area's rural character and appearance.
- 9. Guidance within the Council's Conversion and Renovation of Rural Buildings Supplementary Planning Guidance (SPG) refers to new garages rarely being acceptable and garage parking should be accommodated within the rural building or other existing buildings within the curtilage. The appellant refers to the existing garage at the site not being fit for purpose and being too small to accommodate a modern car. Whilst this may be the case, I do not consider this to be sufficient justification to outweigh the harm identified above.
- 10. The appellant refers to a nearby recent development permitted by the Council which they cite has a greater visual impact on the surrounding rural area. Nevertheless, from the available information I do not consider that this is a good example to follow and in any event, it does not have any visual influence on the immediate context of the appeal development which I have therefore determined on its merits.
- 11.I concur that as the harm I have identified is localised to the immediate rural setting of the appeal site, there would be no material harm to the important landscape character of the wider SLA. However, this does not alter my conclusions that, for the reasons give above, the development is harmful to the rural character and appearance of the area, contrary to Policies MD2, MD11 and MD12 of the LDP and the objectives within the SPG.

#### Conclusion

- 12. For the reasons given above, and having regard to all matters raised, I conclude that the appeal is dismissed.
- 13. In reaching my decision, I have taken into account the requirements of sections 3 and 5 of the Well-Being of Future Generations (Wales) Act 2015. I consider that this decision is in accordance with the Act's sustainable development principle through its contribution towards one or more of the Welsh Ministers' well-being objectives.


