Welsh Government – 'Road Safety in Wales' consultation

Road Safety Strategy Consultation Overview

We want to hear your views about the safety on and of our roads, to help us understand your priorities and how we can best make our roads safe for all.

We will use the responses to this consultation, alongside our engagement with stakeholders that work in the ambit of road safety, a randomised representative sample survey of the Welsh population and workshops that include marginalised groups, to create a new Strategy for Road Safety in Wales.

Introduction

We consider deaths and serious injuries on our roads to be morally unacceptable, and so we are committed to eliminating them (this is called "Vision Zero"), and we feel everyone should do their part in working towards that commitment. This means a new, more proactive approach to road safety that aims to eliminate risks where possible and make our communities safer, healthier, and more sustainable places. We will do everything we can and encourage our partners to make safety improvements to the road network, encourage the use of safe speed limits depending on the type and function of the road, encourage behaviour change, influence vehicle safety and an effective post-crash response by emergency services and meaningful victim support.

Pre-Application Consultation - Dŵr Cymru Welsh Water (DCWW)


Dŵr Cymru Welsh Water (DCWW) are proposing to submit a full planning application for the following: 'The Expansion of the existing Waste Water Treatment Works to include the following: Inlet Works, Trickling Filter, Buried Humus Tanks, Sludge Holding Tank, Motor Control Centre Kiosk, Reed Bed, Reed Bed Blower Kiosk, Alkalinity Dosing Kiosk, Trickling Filter Distribution Chamber, De-sludge Pumps and Slabs, Landscaping, Internal Access Road, Lighting, along with a Temporary Contractor's Compound and Construction Access'.

The proposal is taking place at DCWWs existing treatment works in St Nicholas. The extension to the existing treatment works is required to meet the current and future population growth in the area and to meet the new consents required under Asset Management Plan 7.

The draft application documents can be accessed through the provided web link below for a duration of 28 days. There will follow a formal submission of the application to the Local Planning Authority.

Place-Check for community planning engagement

What is Placecheck?

Placecheck is the simplest way of finding out what a place and its people can tell us, and starting the process of making change happen. A Placecheck can be carried out for a street, a park, a neighbourhood, a town centre or any other place. Placechecks have been carried out in the early stages of neighbourhood planning and a wide range of local initiatives.

You can use the Placecheck web app on your smart phone, tablet or computer, walking about the area or at home. This builds up a set of markers on an online map, and a downloadable online resource of information and opinion on the place, its strengths and weakness, and what needs to be done. The app is easy to use and there is nothing to download. You just click on a link, which takes you to a map of your area.

Who should be involved in the Placecheck?

It is up to you to decide who should be invited to take part in the Placecheck. Sometimes just a handful of people will take part in the first one, and more people will take part in later Placechecks of the same area. A Placecheck is not a means of making a democratically representative assessment of an area. It is a way of getting the ball rolling, and of getting people talking and thinking. It can feed into democratic and representative structures later.

Go walkabout

A Placecheck consists of one or more walkabouts, followed by discussion of the information and opinions they turn up, and some serious thinking about the next steps and who needs to be involved. Using the Placecheck app enables you to extend the Placecheck over several weeks, if that is appropriate, with the results being available permanently online.

Placecheck's simple idea is that much of what needs to be known about a place can be seen and understood by looking at it, or is in the heads of the people who live, work or play there. Placecheck is the simplest, quickest way of finding out what the place and its people can tell us, and starting the process of making change happen.

Placecheck gets us asking three questions:

- What do we like about this place?
- What do we dislike about this place?
- What do we need to work on?
